

Privacy Policy

Awemaze, Inc. Privacy Policy Effective Date: August 3, 2015

At Awemaze, maintaining the trust of our users is of the utmost importance to us. We have developed this privacy policy to explain how we collect, use, share and disclose information about our users, and to show our commitment to fair information practices and the protection of your privacy. We do not sell any personal or other identifying information about our users. Information that we collect will be shared as described in this policy so that we can operate the Awemaze application (the "App") and deliver the information and services offered by the App to our users, but we do not and will not provide your information to any third parties not having a legitimate need for that information in connection with our business and our operation of the App.

Background

The App allows you to upload content in a variety of forms (photos, audio and video files, text descriptions, etc.), in order to describe and showcase your accomplishments and other "highlights" from your life. This information is then available to other users of the App, and allows us to help you attempt to connect to other App users, and to send messages to other users with whom you have connected. In order to use the App to share your information, to access information provided by other users, and to send contact requests to other users, you will need to be a registered user, and it is your responsibility to protect your account and make sure that no one else has access to your password or uses your Awemaze account. You are responsible for all activity that occurs using your account, even if done by someone other than you, and even if done without your permission or knowledge, unless we determine that you were the victim of fraud, hacking or other criminal activity that goes beyond just unauthorized use of your account. By using the App, you are confirming for us that you are in agreement with this privacy policy and with any other privacy policies or practices that we may provide to you from within the App.

The App may at times refer you or link you to websites operated by third parties, or may provide you with URLs or other information so that you can access third-party websites. These third-party all have their own privacy policies and practices, which may differ materially from Awemaze's policies and practices. This policy does not apply to any data collected or used by any third parties that may have access to your information as a result of your use of the App. It is your responsibility to read and confirm your agreement with the privacy policies and practices of any and all third-party websites, whether you access them from within or from outside the App.

Collection and Use of Information

When you register as a user of the App, and from time to time in connection with your use of the App, we may collect and store the following types of personal information:

Account Info: We will collect, at a minimum, your full name, email address and/or mobile phone number, and a password of your choosing, together with any other information that you provide to us during your account registration or that you otherwise include as part of your profile or "highlights" information.

Location Information: If you enable location services on your device, we will collect your current location (any time you open or access the App). We will also use any location information that you enter manually, whether as part of your registration or profile information, or in connection with any other information you input into the App.

Contacts Information: With your permission, the App may be able to gain access to the contacts that you have stored on your device, in order to send email messages to your contacts or to otherwise establish or facilitate connections between and among you and the other users in your network. You may also have the option to upload one or more of your contacts to the App, in which case the App will store any information that you designate for upload, and we will use that information to help you grow and extend your network, and to enhance your App experience by (for example) identifying any of your contacts that are also App users, and helping you invite your contacts who are not App users to download and try the App.

Social Media Accounts: The App may ask you to connect your App to your Facebook, Twitter, Instagram or other social media accounts, and if you provide the information and approvals necessary to make one or more of those connections, the App will use the account information that you provide in order to post to your account(s) on the social media platforms that you have connected to the App.

Credit Card Info (optional and when/as available): If at any time the App should give you the option to make purchases or otherwise provide payment information, then in connection with purchases or other payments, we will give you the option to provide a number, expiration date, CVV code, and name and billing address information for one or more of your credit cards.

We use the personal information we collect in the following ways:

Account Access: Your email and password are used to validate your identity on login, and your email or mobile phone number may be used to send a "reset password" link when requested.

User Profiles and Connections: Your name and information about you and your accomplishments will be displayed for review by other users of the App, and your email or mobile phone number will be used to notify you any time another user has requested a connection with you.

Purchases: If we decide to enable purchases or other payment options, your name, address and credit card information will be used to make payments via the App.

Other Notices: Your email or mobile phone number may be used to let you know about changes to this policy or to our terms of use, or to contact you about your use of the App, or to reply to any support issues or other questions.

We may also collect and use anonymous information – such as mobile device type and connection information, as well as usage and traffic data – that does not specifically identify any user, but that may help us improve the App and the services we offer, and that may be shared with our business partners (but only on an aggregate and anonymous basis).

Additional Information

We may disclose your personal information if we determine that we are required to do so:

- To comply with applicable laws, or with legal process served on us;
- To protect or defend our rights or the rights of any of our users or business partners;
- To enforce our terms of use or other agreements; or
- To protect anyone's rights, property or safety.

We may revise this policy from time to time - e.g., to keep up with changes in law, or to reflect changes in how we are doing business – and so you should review this policy periodically to make sure you are ok with our current privacy practices. The App will always include our most up-to-date privacy policy, and we include an effective date at the top of the policy, so you can quickly see when we last updated the policy.

None of the App's content or features are directed specifically at children under 13 years of age. If we learn or have reason to suspect that a user of the App is under age 13, we will promptly delete any information stored about that user.

In addition, if we should ever sell our company or the App to a third party, then we expect that our database of user information would be one of the assets sold in such a transaction, and we would ask that the buyer notify you of any changes to this policy after the sale closes.

We understand that some users may have enabled a "do not track" feature in their web browsers; however, consistent with and to the maximum extent permitted by applicable law, we do not honor any "do not track" requests sent from a web browser.
